Sub: Disclosure on impact of COVID-19 on the business of the Company pursuant to the SEBI circular no SEBI/HO/CFD/CMD1/CIR/P/2020/84 dated May 20, 2020

Further to our disclosures dated May 29, 2020 on impact of Covid-19 on the business of the Company, an update relating to the impact is provided herewith:

1. Impact of COVID- 19 on the Business:

The Company is into the business of operating Digital Media Website & MICE. The Company generally organizes 'On Ground Conferences', however in wake of CoVID 19 virus outbreak restrictions imposed on free movement of people by the central/state governments and strict adherence to social distancing, the Company has started organizing Virtual Conferences. The total impact on the operations of the Company cannot be completely assessed at this stage.

2. Ability to maintain operations including the office spaces closed down:

The Company has implemented 'Work from Home' for all the employees of the Company. The Company keeps the safety and sound health of the workforce, partners and their families at the utmost priority.

Also, in the absence of transport facilities, the Company is continuously following 'Work from Home' Policy.

The Company has started virtual conferences / visionary talk with eminent personality of social and government sectors of our Country and accordingly trying to maintain the operation of the Company on track.
